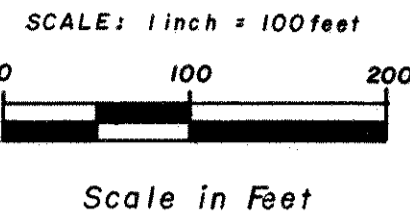


ZACHMAN'S THIRD ADDITION

KNOW ALL PERSONS BY THESE PRESENTS: That Zachman Homes, Inc., a Minnesota Corporation, owner of the following described property situated in the Township of White Bear, County of Ramsey, State of Minnesota:

The East 33 feet of the North 1/2 of the Northeast 1/4 of the Southwest 1/4 of the Southeast 1/4 except the North 180 feet thereof, the South 1/2 of the Northeast 1/4 of the Southwest 1/4 of the Southeast 1/4, and the North 1/2 of the Southeast 1/4 of the Southwest 1/4 of the Southeast 1/4, all in Section 10, Township 30 North, Range 22 West, according to the United States Government Survey thereof.

The Easterly 53 feet of the following described property: All of the North 1/2 of the Northwest 1/4 of the Southwest 1/4 of the Southeast 1/4 except the West 430 feet thereof, and except all that part lying East of the West 550 feet and North of the South 130 feet thereof, of Section 10, Township 30 North, Range 22 West, according to the Government Survey thereof, Ramsey County, Minnesota.

The North 1/2 of the Northeast 1/4 of the Southwest 1/4 of the Southeast 1/4, except the East 600 feet of the North 180 feet thereof; also except the East 33 feet of that part lying Southerly of the North 180 feet thereof also except that part described as follows: Commencing at a point on the North line of said 1/4 1/4 Section, 450 feet West of the East line, thence South 180 feet to the point of beginning of parcel to be described thence deflecting 44°05'30" right, 104.55 feet; thence Northwesterly at right angles 108.26 feet to a point 60 feet Easterly of the West line of said 1/4 1/4 section and 180 feet South of the North line of said 1/4 1/4 Section, thence Easterly to the point of beginning, all in Section 10, Township 30 North, Range 22, according to the United States Government Survey thereof.

The West 5 acres of the North 22 acres of the Southeast 1/4 of the Southeast 1/4 of Section 10, Township 30, Range 22, according to the United States Government Survey thereof, except roadway and except the East 150 feet thereof, and also except the West 120 feet of the North 333 feet thereof.

Have caused the same to be surveyed, platted and known as ZACHMAN'S THIRD ADDITION and do hereby dedicate to the public for public use forever the streets, lanes and drainage and utility easements as shown on the plat. 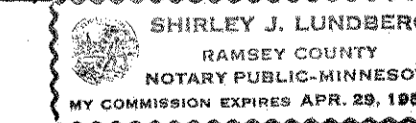
