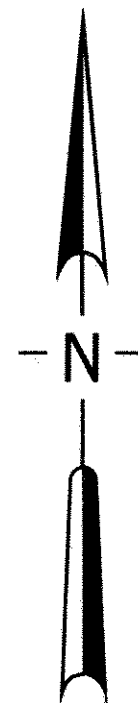
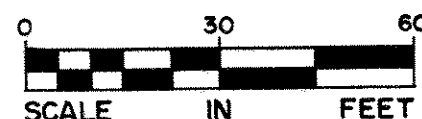
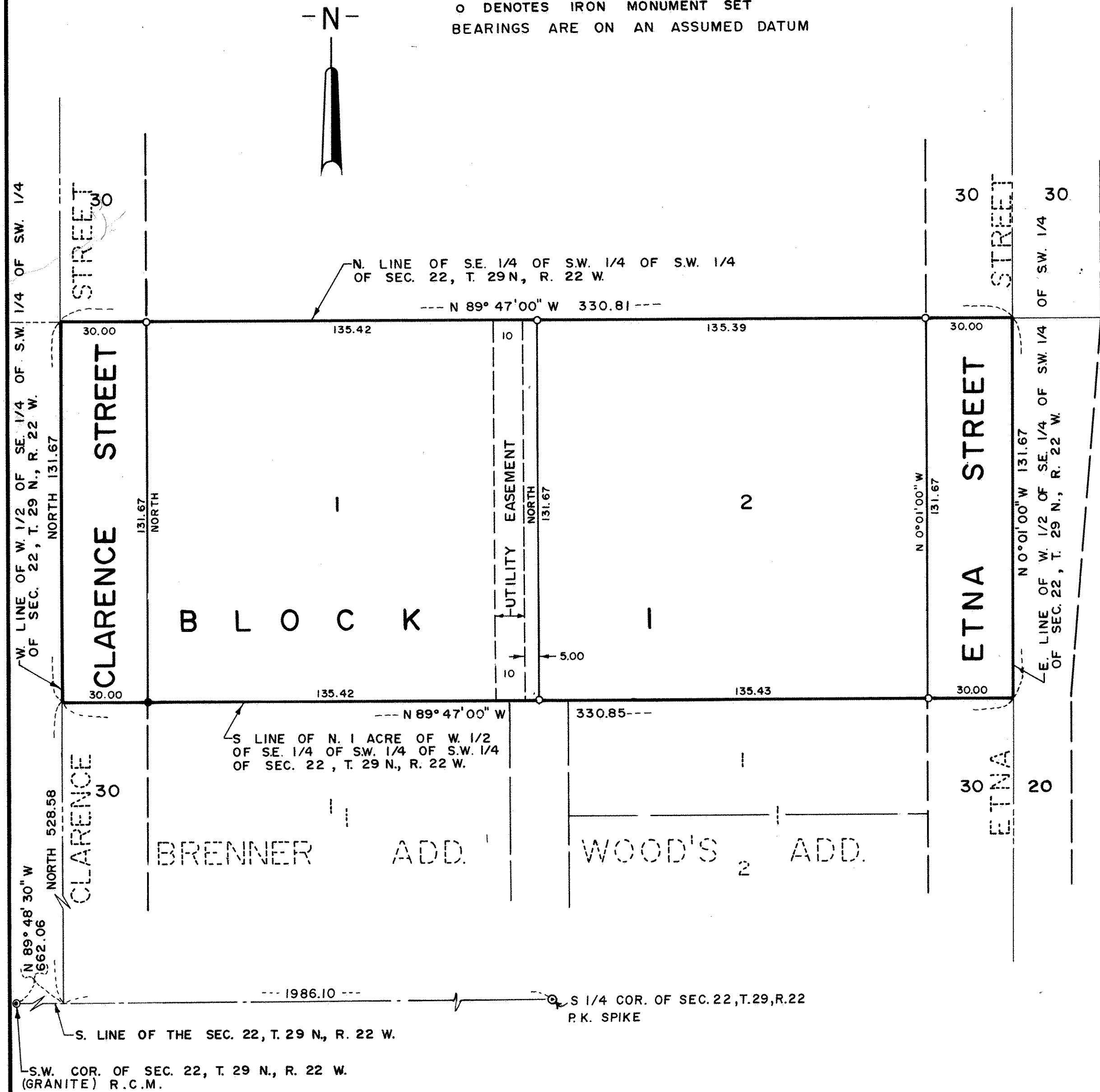


# BAUMAN ADDITION

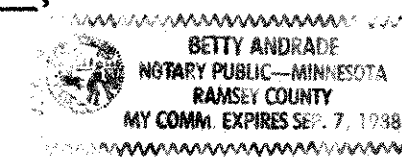

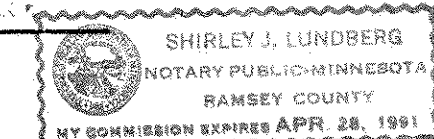
