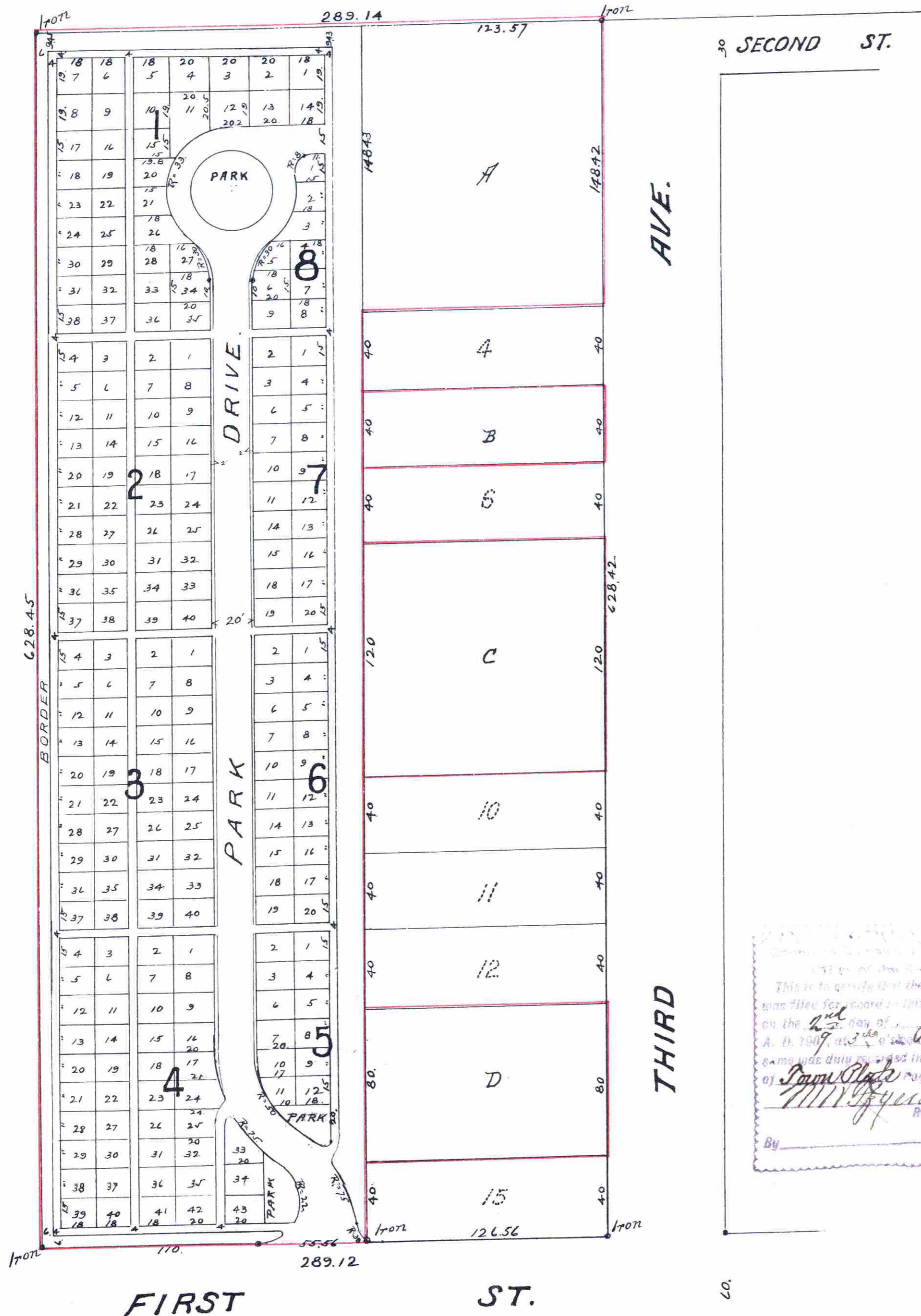


# ST. JOHN THE BAPTIST CEMETERY.
