Terry** the proprietors of Terry's Addition to the City of Saint Paul, County of Ramsey, and State of Minnesota, do hereby certify that we have caused the same to be surveyed and subdivided into Lots and Blocks as indicated in the foregoing Plat for the purpose of having the same recorded according to Law; and we hereby release our right, title, interest and claim in and to the Streets and Alleys as laid out in said Plat, and we give the same for public use; but said proprietors do not hereby dedicate any part of said land above described for railroad tracks, or railroad purposes, nor release hereby to any railroad now located or hereafter to be located upon or across said land any right of way, easement or any estate or interest therein; and especially reserves herefrom that portion of said land occupied by the line of the Saint Paul, Stillwater, and Taylor's Falls Rail Road as indicated in said Plat.

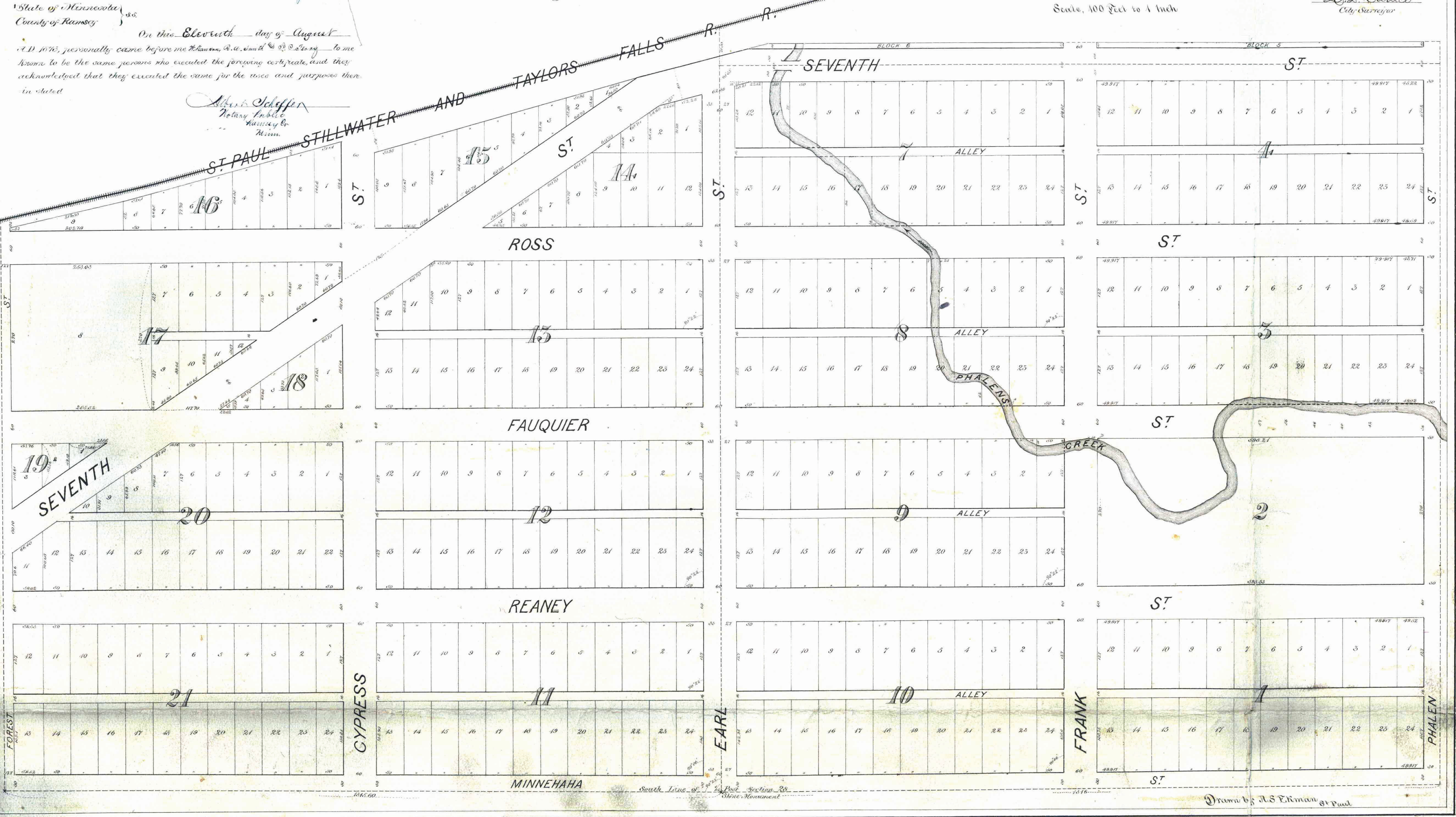
