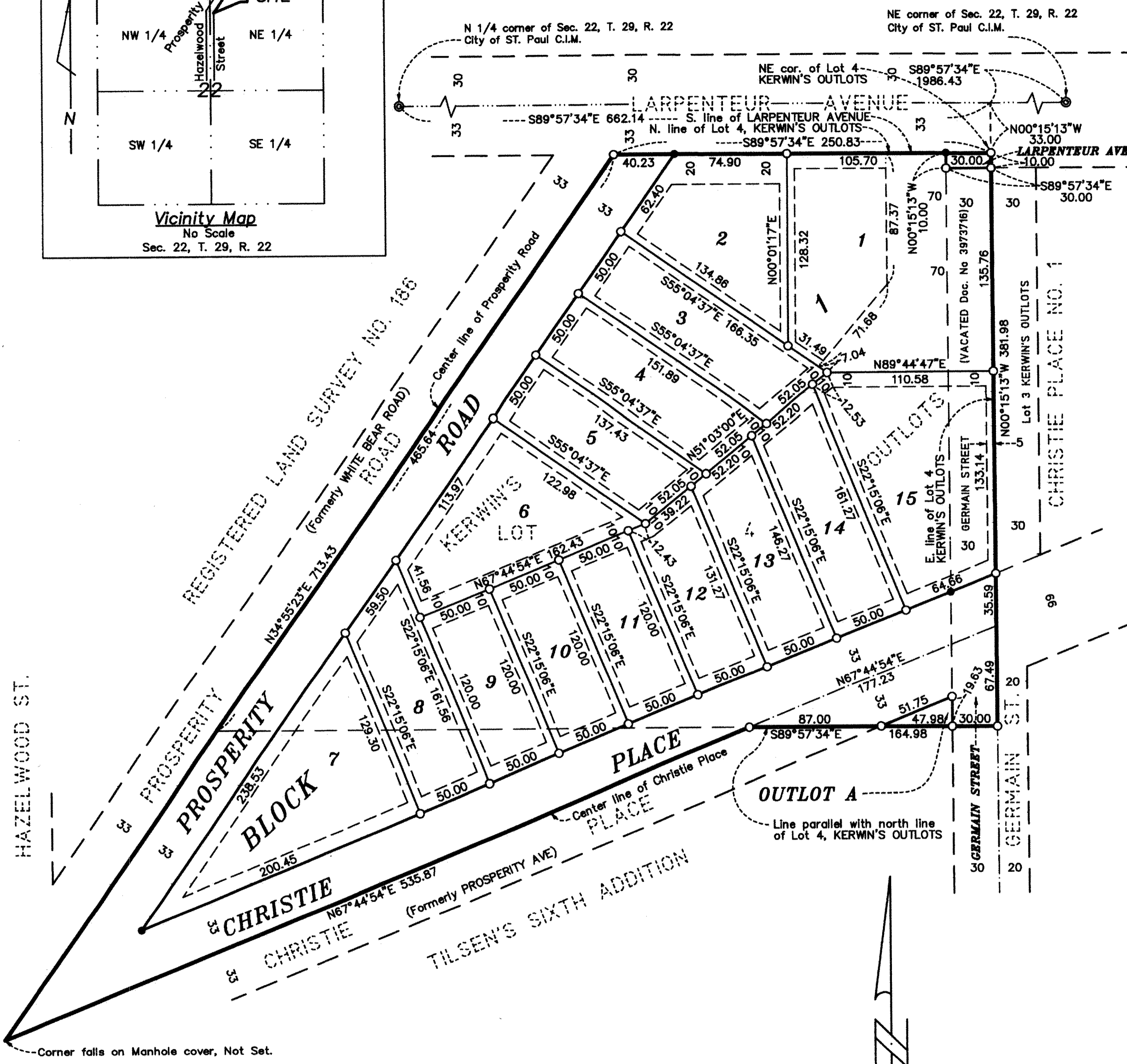
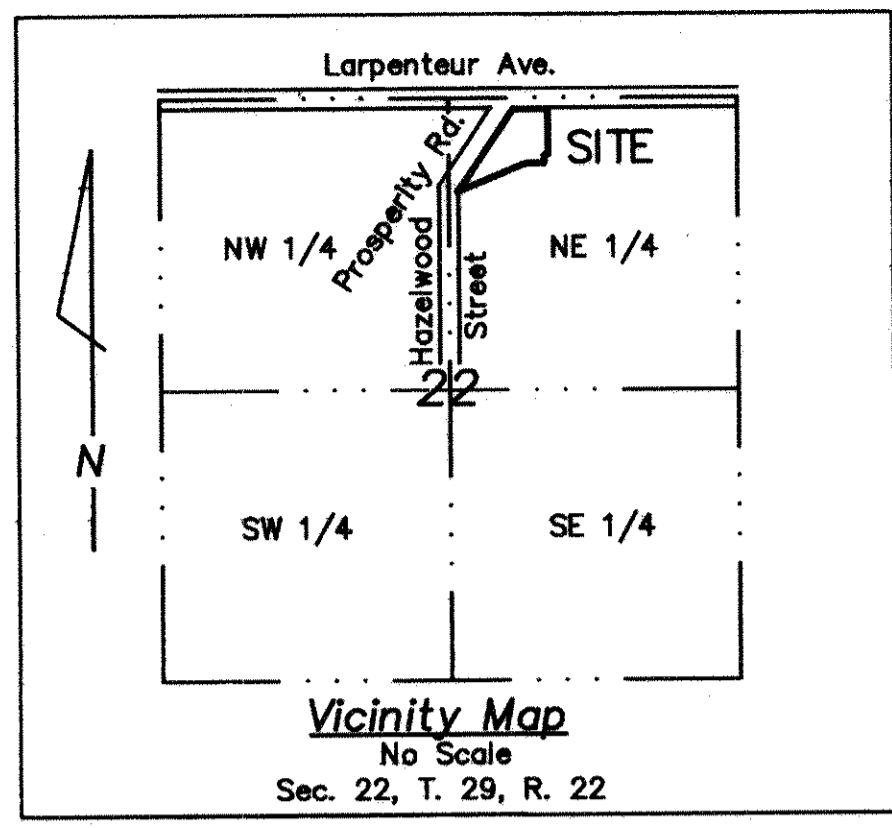


EASTERN HEIGHTS

All that part of Lot 4, KERWIN'S OUTLOTS to the CITY of ST. PAUL, Minn., according to the plat thereof on file and of record in the office of the Register of Deeds in and for Ramsey County, Minnesota, bounded and described as follows: Beginning at the northeast corner of said Lot 4; thence west along the north line of said Lot 4 to the center line of Prosperity Road formerly known as White Bear Road; thence southwesterly along the center line of said Prosperity Road 465.64 feet; thence easterly and parallel with the north line of said Lot 4 to the east line of said Lot 4; thence northerly along said east line of said Lot 4, to the place of beginning;

And also all that part of Lot 4, KERWIN'S OUTLOTS to the CITY of ST. PAUL, Minn., according to the plat thereof on file and of record in the office of the Register of Deeds in and for Ramsey County, Minnesota, described as follows: Beginning at a point in the center of Prosperity Road formerly known as White Bear Road in said Lot 4, 465.64 feet southwesterly from the south line of Larpenteur Avenue; thence easterly parallel with the north line of said Lot 4 to the center line of Christie Place formerly known as Prosperity Avenue; thence southwesterly along the center line of said Christie Place to the center line of Prosperity Road formerly known as White Bear Road; thence northeasterly along the center line of said Prosperity Road to the place of beginning.

Has caused the same to be surveyed and platted as EASTERN HEIGHTS and does hereby dedicate to the public for public use forever the thoroughfares and drainage and utility easements as shown on this plat.

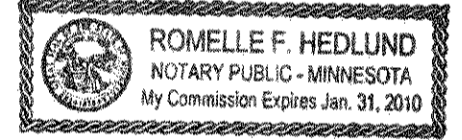

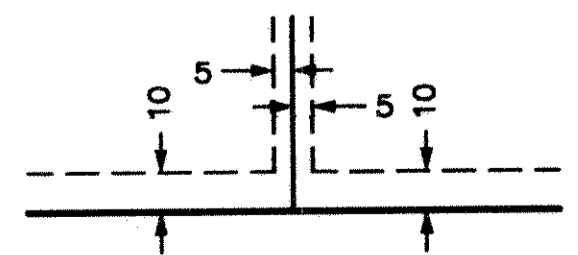
