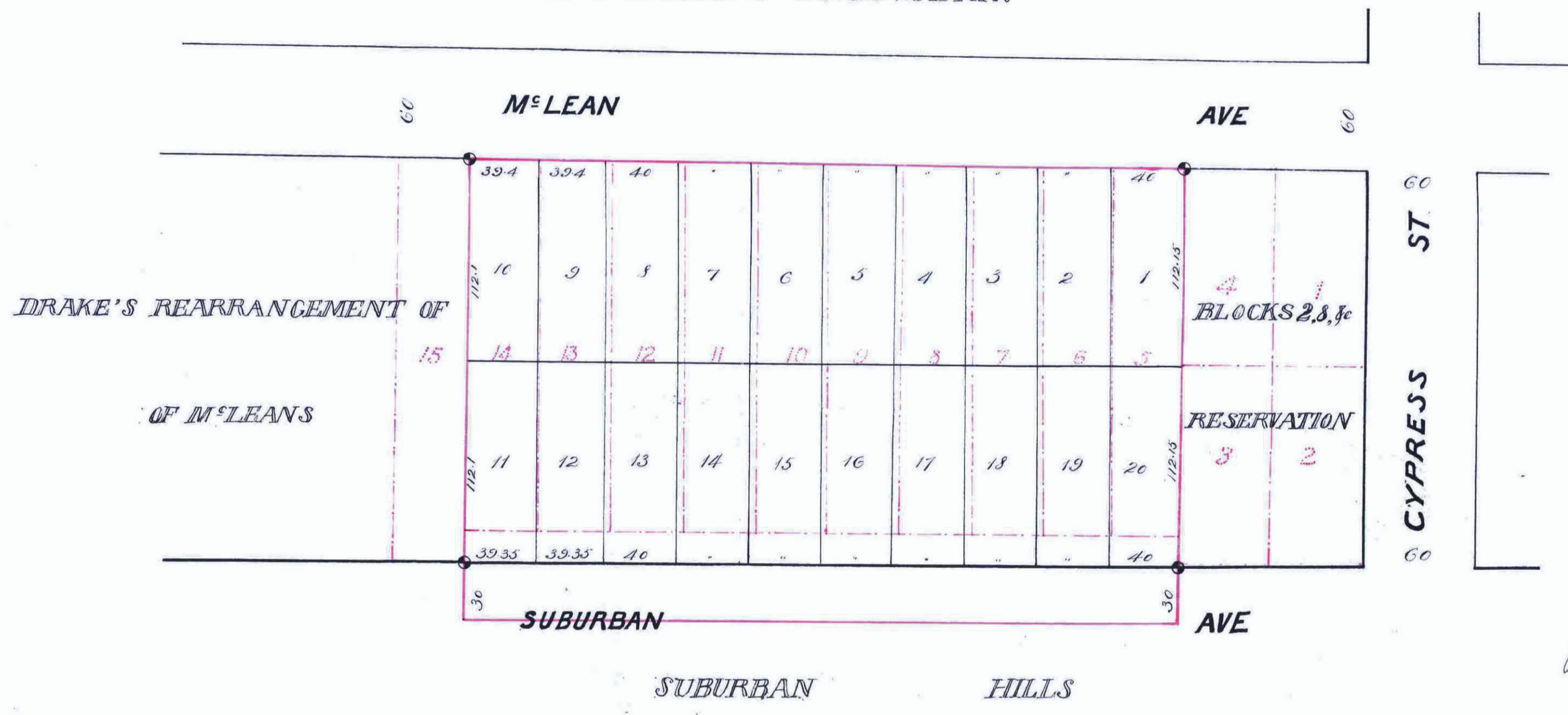


DOUGAN AND CURRY'S ADDITION TO THE CITY OF ST PAUL RAMSEY CO MINN
