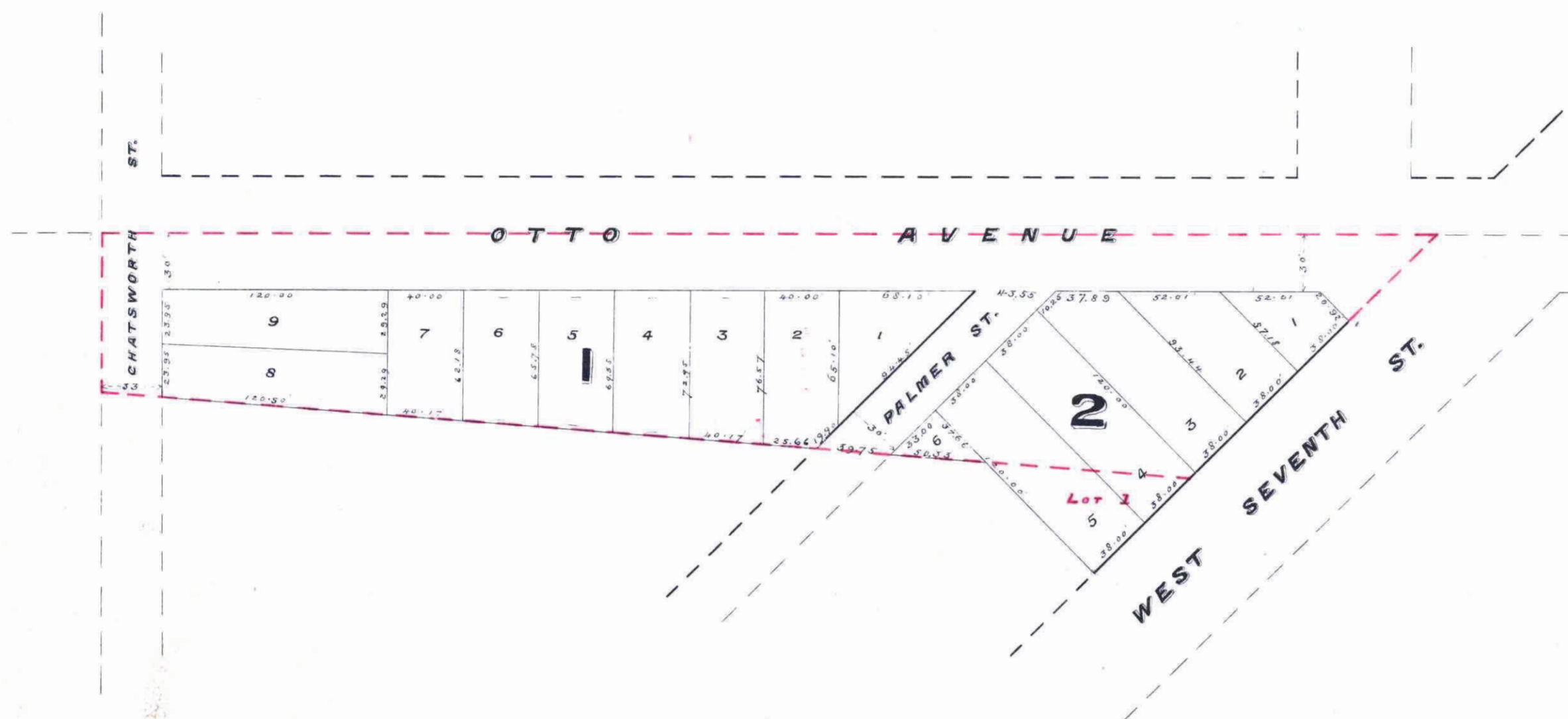


# MAP OF MOLLERS' ADDITION

Moller his wife proprietors of all that portion of the NE 1/4 of the NW 1/4 of section 14, Township 128 N, Range 103 W, about three feet in the City of St. Paul, described as follows to-wit: Commencing at a point on the north line of said section 14, about 61.50 feet West from the North quarter section 14, part of said section No. 14 and being also the point of intersection of the North line of said section with the east line of section 14, thence north on said North line of section 14, 706.20 feet to the North West corner of the North east quarter of the North half of section 14, thence South on East line of the North half and West half of the said North West 1/4 of section 14 to the North boundary of said addition to the North line of West 7th Street, thence North East, along the said North line of West 7th Street to the point of Commencement containing one and one half acres of land more or less and also all that NW 1/4 of section 14, thence East to the City of St. Paul, has caused the same to be surveyed and platted and laid off thereon as Moller's Addition as shown by the plat and hereby dedicates to the public and for the public use, all the streets, avenues and alleys as herein indicated.
