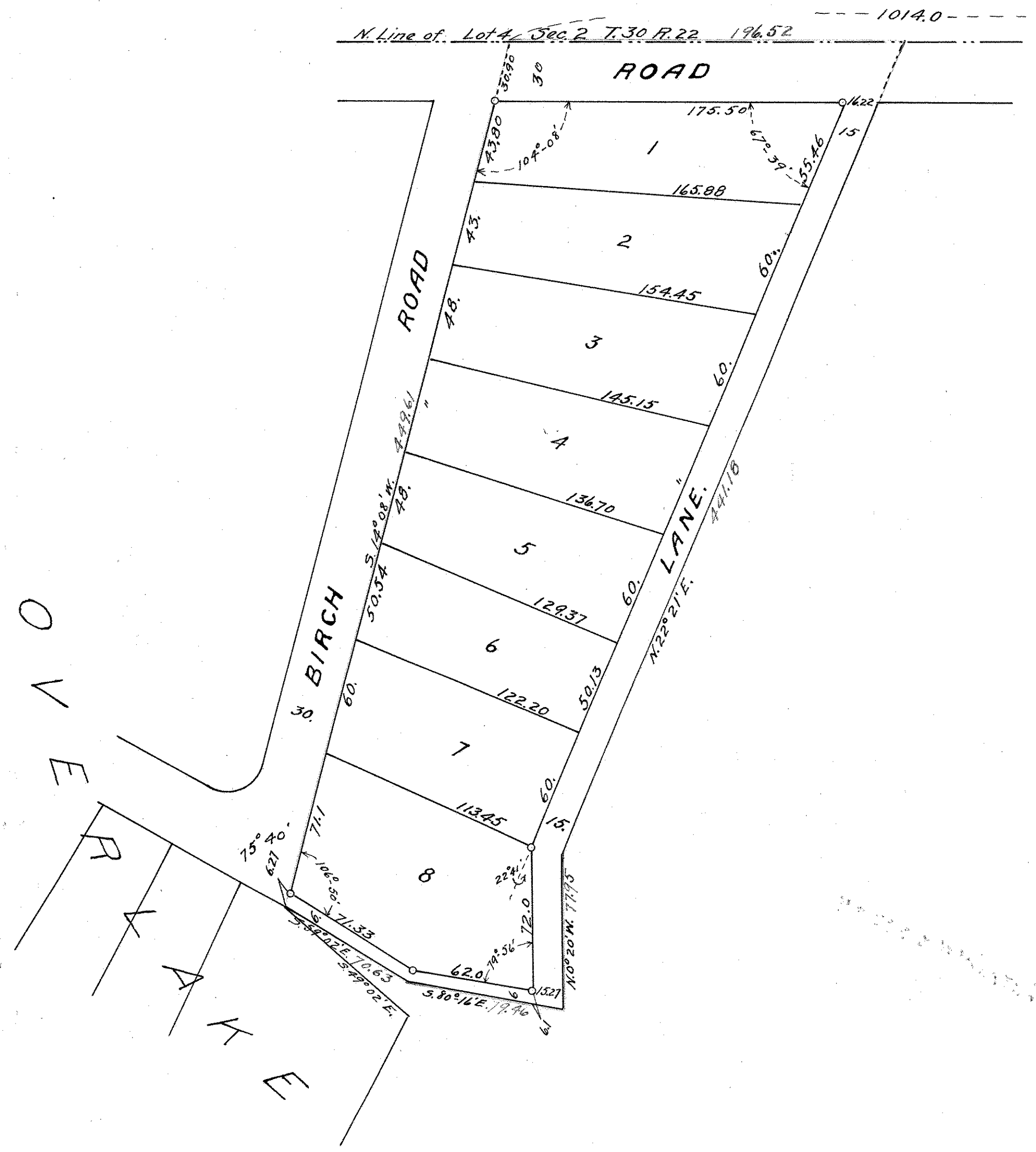


# OVERLAKE SECOND.
