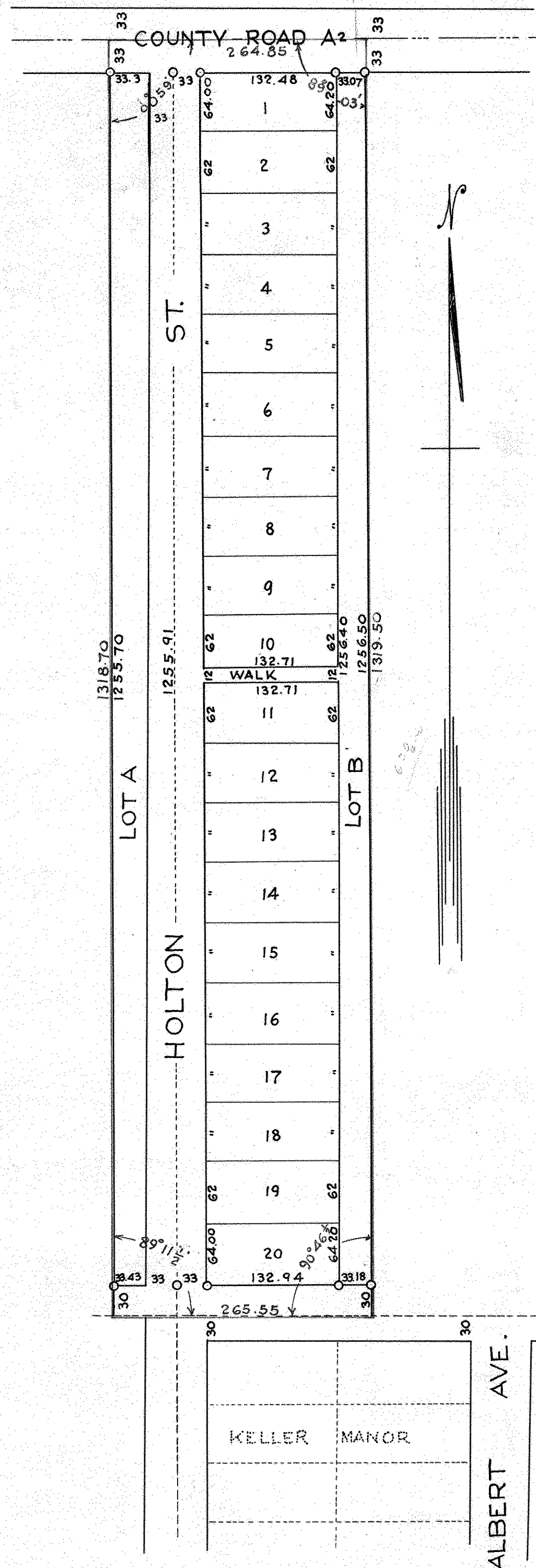


# MIDWAY PLAINS
