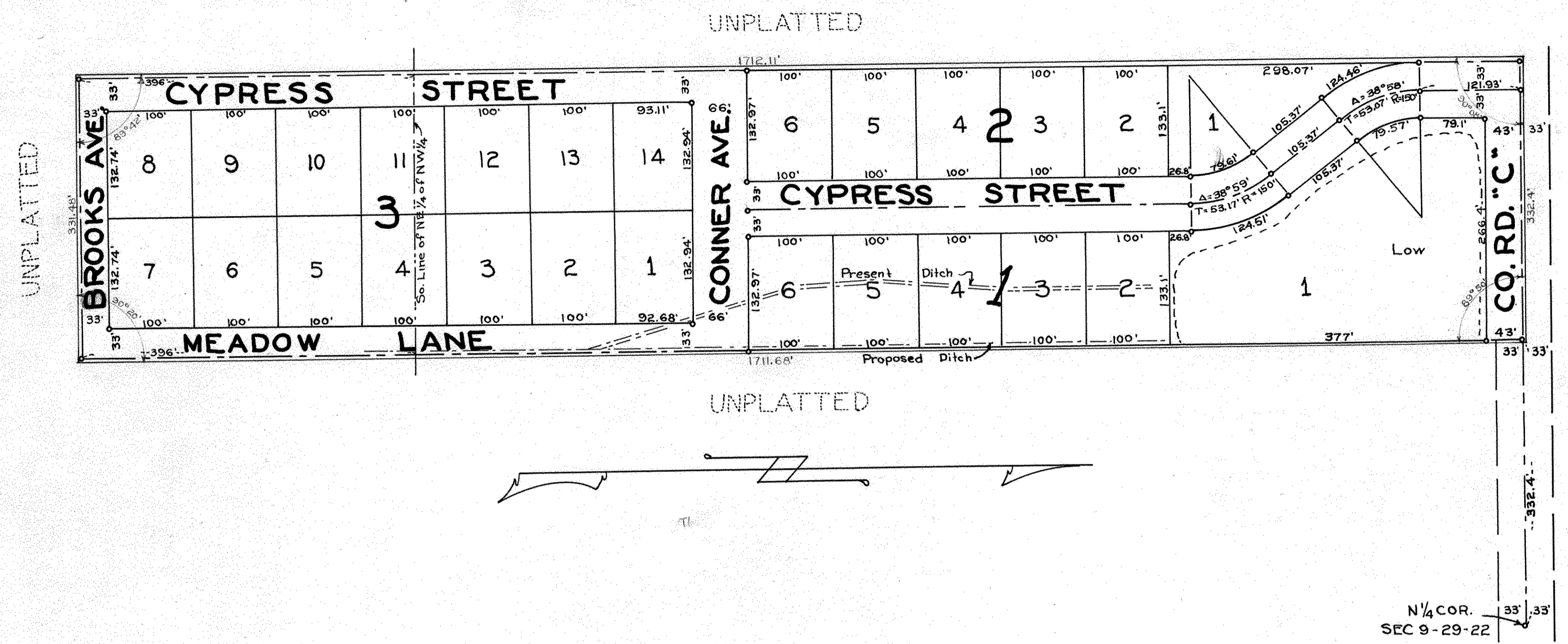


# PETERS ADDITION
