Spiegler, husband and wife, and Sam Spiegler and Anna Spiegler, husband and wife, owners of that part of the West ½ of the Southwest ¼ of Section 1, Township 29, Range 22, Ramsey County, Minnesota lying Southerly of the following described line to wit: Commencing at a point on the West line of said West ½ of Southwest ¼ distant 1501.00 feet North from the Southwest corner thereof; thence Easterly deflecting to the right from said West line 89 degrees 57 minutes 45 seconds for a distance of 175.00 feet; thence on a tangential curve to the right having a radius of 963.60 feet for a distance of 190.67 feet; thence on a line tangent to the last mentioned curve a distance of 20 feet; thence on a tangential curve to the right having a radius of 249.35 feet for a distance of 190.67 feet; thence on a line tangent to the last mentioned curve a distance of 20 feet; thence on a tangential curve to the right having a radius of 855.13 feet for a distance of 248.44 feet; thence on a line tangent to the last mentioned curve a distance of 196.60 feet, more or less, to a point on the East line of said West ½ of Southwest ¼ distant 1355.00 feet North from the Southeast corner thereof and there terminating, except the South 242 feet of the West 242 feet of said West ½ of Southwest ¼ and except the Southerly 286 feet of the Easterly 650 feet of said West ½ of Southwest ¼ have caused the same to be surveyed and platted and hereafter known as SARATOGA HILLS as shown by this plat, and hereby dedicate to the public and for the public use forever all Avenues, Roads, and Drive as shown, and subject, however, to the easements for utility purposes as shown.
