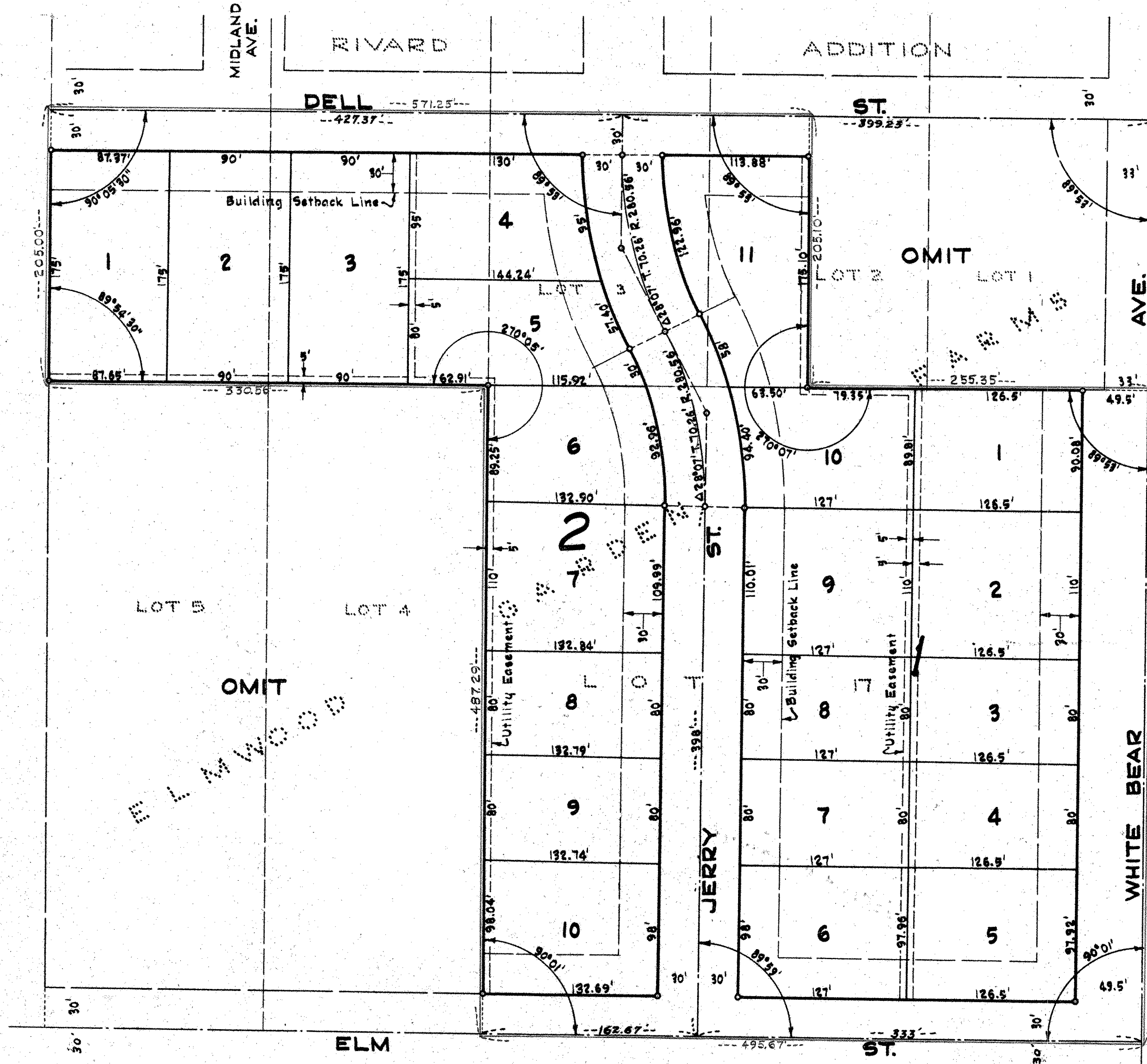


HALONEN ADDITION
