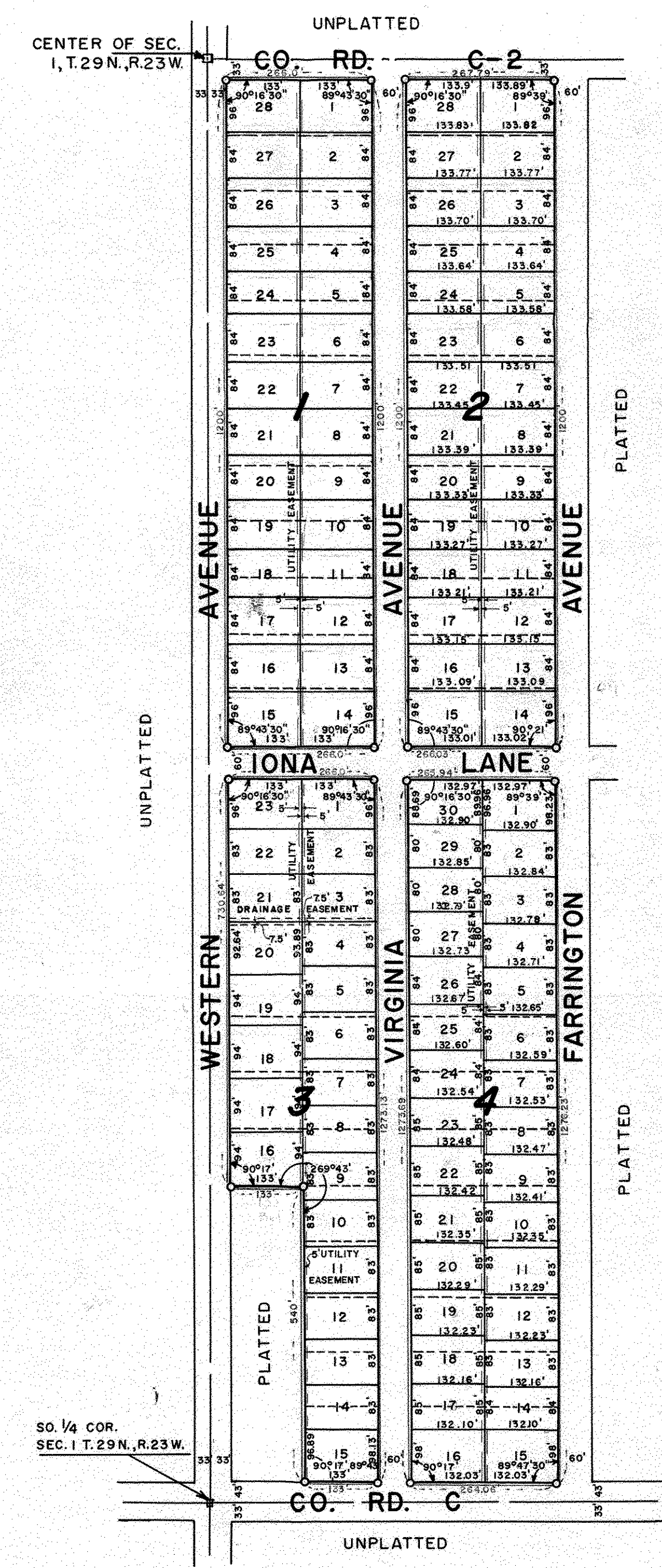


# KROISS EASTWOOD ADDITION
