


# ZIMMERMAN OFFICE PARK

The East 330 feet of the Southwest Quarter (SW $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 10, Township 29, Range 23; West one half of the Southeast Quarter (SE $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 10, Township 29, Range 23, except that part of the East 330 feet of the Southwest Quarter (SW $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 10, Township 29, Range 23 lying North of a line parallel with and distant 912.67 feet Northerly measured at right angles from the South line of said Section, also except subject to County Road "B" that part of the Southwest Quarter (SW $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 10, Township 29, Range 23, Ramsey County, Minnesota described as follows: Beginning at the intersection of the South line of said 14 $\frac{1}{4}$  section with a line parallel with and 60 feet West of the East line of said 14 $\frac{1}{4}$  section; thence North along said 60 foot line, a distance of 357.0 feet to an iron monument and the beginning of a curve bearing Northwesterly; thence Northwesterly along a curve with its tangent parallel to County Road "B" and a radius of 357.20 feet, a distance of 185.0 feet; thence Southwesterly 194.80 feet to the intersection of a line 340.0 feet West of and parallel with the East line of said 14 $\frac{1}{4}$  section at a point 239.0 feet to the North of the South line of said 14 $\frac{1}{4}$  section; thence South along said parallel line 239.0 feet; thence East 280.0 feet to the point of beginning, all according to the Government Survey thereof, subject to the rights acquired by the State of Minnesota for highway purposes as shown by the records in the Office of the Register of Deeds, Ramsey County, Minnesota, have caused the same to be surveyed and platted and hereafter known as "ZIMMERMAN OFFICE PARK" as shown by this plat and hereby dedicate to the public and for the public use forever all roads, malls, avenues and streets as shown.
