
## RICE CREEK VILLA SECOND ADDITION

That part of the NE 1/4 of Section 18, Town 30 N, Range 23 W, Ramsey County, Minnesota described as follows: Beginning at the intersection of the West line of said NE 1/4 and the South right-of-way line of Minnesota Belt Line right-of-way; thence South along the West line of said NE 1/4, 199.46 feet; thence deflecting 90° left, 40 feet; thence along a tangential curve to the right having a radius of 271.97 feet, central angle of 23°21', arc length of 110.84 feet; thence Southeasterly to the Southwest corner of Lot 1, Block 1, RICE CREEK VILLA; thence Northwesterly along the West line of said Lot 1 to the Northwest corner of said Lot 1; thence Northwesterly along the South right-of-way line of Minnesota Belt Line Railroad to the point of beginning and there terminating; subject to Silver Lake Road and easements of record.
