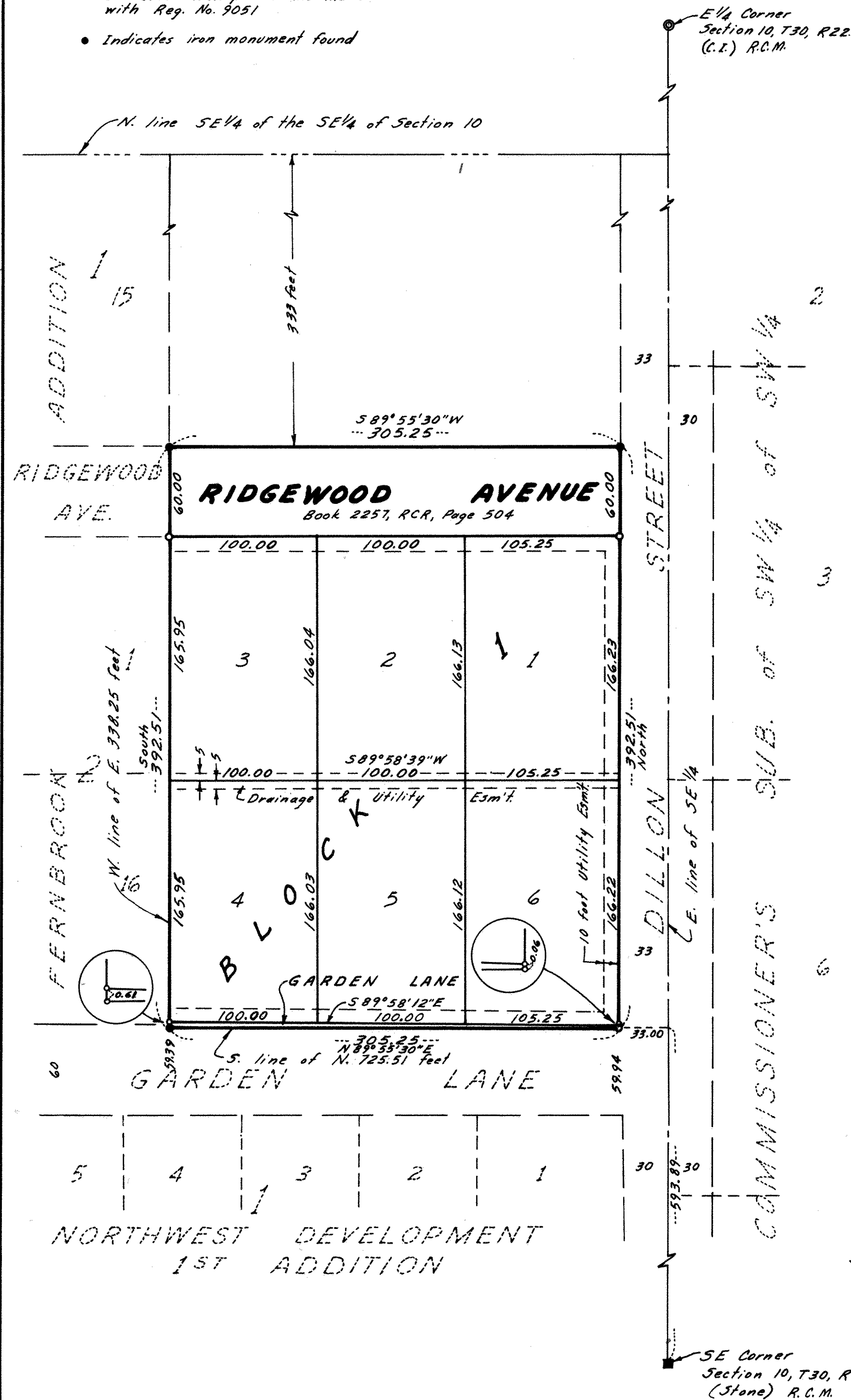


PARENTEAU ADDITION

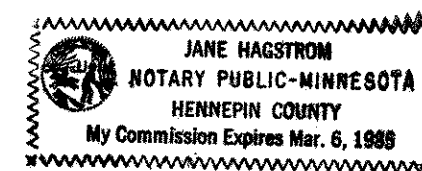

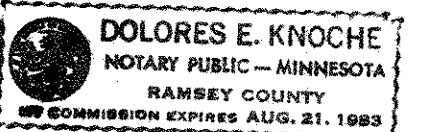
