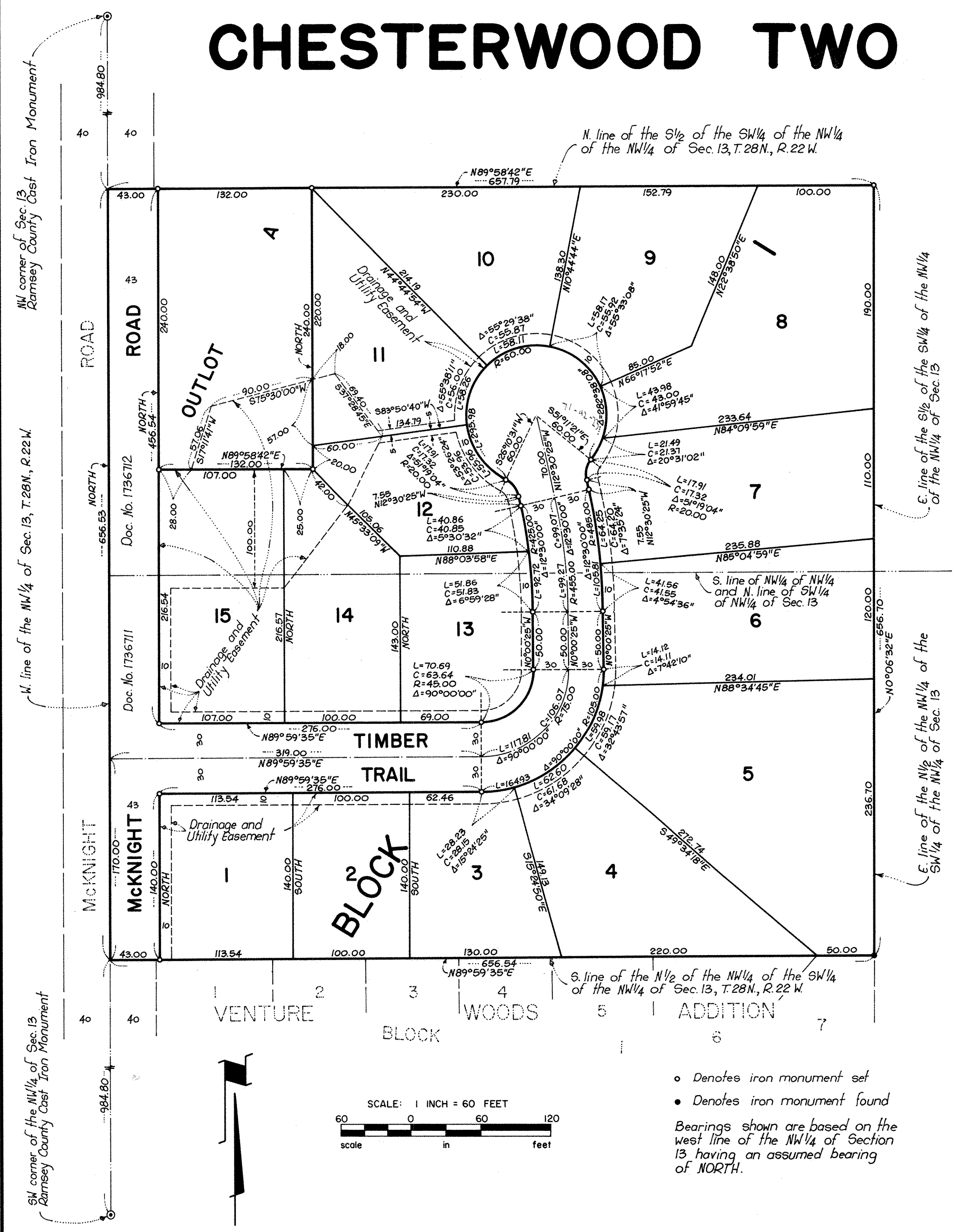


CHESTERWOOD TWO

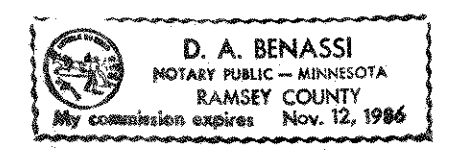
