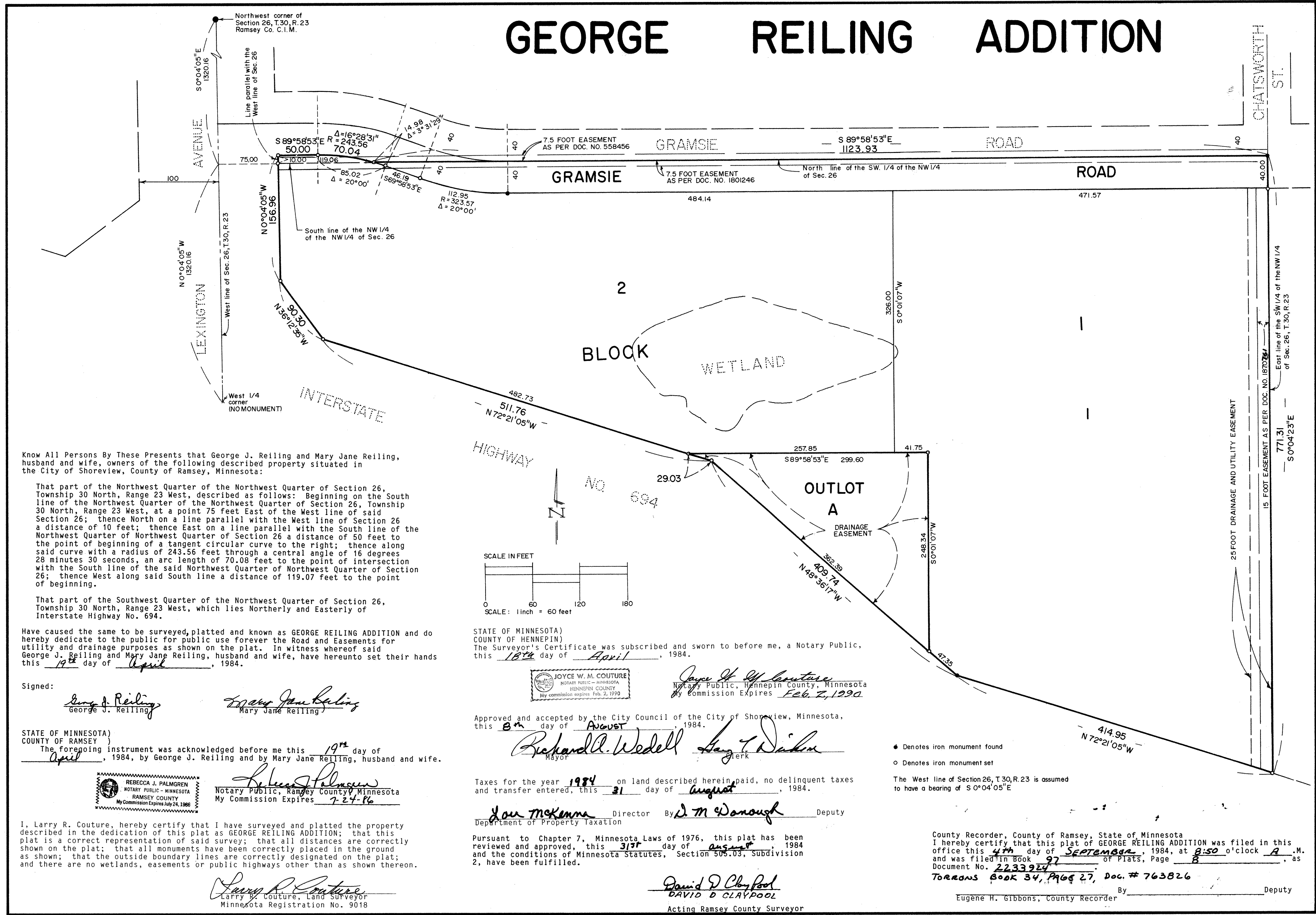


GEORGE REILING ADDITION



Know All Persons By These Presents that George J. Reiling and Mary Jane Reiling, husband and wife, owners of the following described property situated in the City of Shoreview, County of Ramsey, Minnesota:

That part of the Northwest Quarter of the Northwest Quarter of Section 26, Township 30 North, Range 23 West, described as follows: Beginning on the South line of the Northwest Quarter of the Northwest Quarter of Section 26, Township 30 North, Range 23 West, at a point 75 feet East of the West line of said Section 26; thence North on a line parallel with the West line of Section 26 a distance of 10 feet; thence East on a line parallel with the South line of the Northwest Quarter of Section 26 a distance of 50 feet to the point of beginning of a tangent circular curve to the right; thence along said curve with a radius of 243.56 feet through a central angle of 16 degrees 28 minutes 30 seconds, an arc length of 70.08 feet to the point of intersection with the South line of the said Northwest Quarter of Northwest Quarter of Section 26; thence West along said South line a distance of 119.07 feet to the point of beginning.

That part of the Southwest Quarter of the Northwest Quarter of Section 26, Township 30 North, Range 23 West, which lies Northerly and Easterly of Interstate Highway No. 694.

Have caused the same to be surveyed, platted and known as GEORGE REILING ADDITION and do hereby dedicate to the public for public use forever the Road and Easements for utility and drainage purposes as shown on the plat. 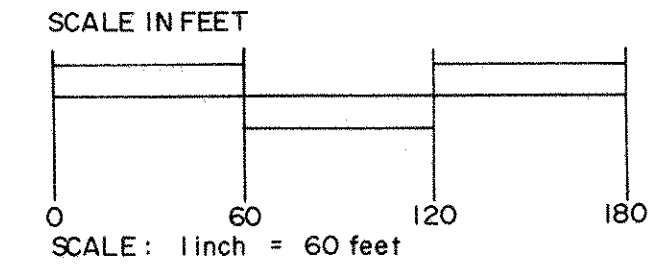
