
ASI SUBDIVISION



Know All Persons By These Presents that BMC Industries, Inc., a Minnesota corporation, fee owner of the following described property situated in the City of White Bear Lake, County of Ramsey, State of Minnesota:

That part of the West Half of the Southeast Quarter of Section 34, Township 30, Range 22, Ramsey County, Minnesota, lying easterly of the Burlington Northern Incorporated Railroad right-of-way, and lying northerly of the following described line:

Commencing at the northeast corner of said West Half of the Southeast Quarter; thence South 00 degrees 04 minutes 10 seconds East, assumed bearing along the east line of said West Half 1,297.43 feet to the point of beginning of the line to be described; thence North 89 degrees 57 minutes 25 seconds West 621.98 feet; thence northwesterly 350.00 feet along a tangential curve, concave to the northeast having a radius of 286.48 feet and a central angle of 70 degrees 00 minutes 00 seconds; thence North 19 degrees 57 minutes 25 seconds West, tangent to said curve, 193.21 feet; thence northwesterly 256.57 feet along a tangential curve concave to the southwest, having a radius of 286.48 feet and a central angle of 51 degrees 18 minutes 51 seconds; thence North 71 degrees 16 minutes 16 seconds West, tangent to said curve, 50.00 feet to the centerline of said Burlington Northern Incorporated Railroad right-of-way and said line there terminating.

Except that part thereof described as follows:

Beginning at a point on the Easterly right-of-way line of the Northern Pacific Railway (now known as Burlington Northern Railroad Company) 526.09 feet Southerly thereon from the North line of said Southeast Quarter; thence Southerly on said right-of-way line 80 feet; thence Easterly at a right angle to said right-of-way line 130 feet; thence Northerly at a right angle to the last described line 130 feet to the point of beginning.

Has caused the same to be surveyed, platted and known as ASI SUBDIVISION and does hereby dedicate to the public for public use forever the road, circle and drainage and utility easements as shown on the plat.
