GONYEA'S OAK HEIGHTS FIFTH ADDITION



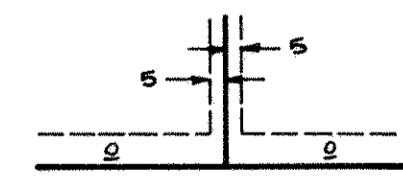
